Membership Agreement

STL Village is a Missouri nonprofit corporation that is tax exempt under 501(c)(3) of the federal income tax law. Its goal is to help residents of the area within its footprint, age 50 and older, to stay at home in their community as they age. **STL Village** does this by connecting its members to the people and services necessary to maintain home, health, hope and happiness. **STL Village** operates on a volunteer first basis; or members may be referred to vetted service providers, some of whom may work at reduced prices. All volunteers sent to members' homes will have had background checks.

Membership to **STL Village** is \$840 annually for a household of two or more, or \$600 for an individual. Associate memberships (those without services) are available at \$420 annually for a household or \$300 for an individual. The membership year runs for 12 consecutive calendar months, **starting with the first day of the month following the date the Membership Agreement is accepted** by **STL Village**. Membership fees are subject to change on any anniversary date. All members are subsidized in the sense that fees pay only a portion of the **STL Village** budget.

In exchange for a person's acceptance by **STL Village** as a member, the member agrees to indemnify **STL Village** from and hold it harmless against any and all loss, expense and liability arising out of or related in any way to (1) the performance of **STL Village** and its agents and (2) the activities of any volunteer or service provider used or recommended by **STL Village**.

Privacy Policy

As part of this agreement, **STL Village** will not give, sell or trade a member's information except in the event of an emergency situation involving the member whereby **STL Village** will contact the emergency contact(s) listed on the member's General Information Form or local emergency resources.

Each of the undersigned applicants for **STL Village** membership states that he/she has read and understands the above terms of membership and agrees that he/she and their respective heirs, successors, agents, and legal representatives will be bound by those terms. When a membership is renewed, it will remain subject to this agreement.
